EDUCATIONAL QUALIFICATION.

Village Revenue Assistant

Must have passed **SSC (10th Class)** Examination conducted by the Andhra Pradesh State Board of Secondary Education or its equivalent Examination.

The applicant shall be the native of the Revenue Village for which the Recruitment is notified.

The Selection of candidates is based on a objective type Written Test for 100 Marks at **SSC** level.

* 50% of questions (30 Marks) will be aimed at testing the knowledge of the candidate on rural areas and rural living conditions.
